





Q: What is Glendale Municipal Airport up to these days?

A: In this crazy environment, the Glendale Municipal Airport is doing fairly well. We have seen ups and downs over the past few months but remarkably our Airport Operations are at the same counts as we were at this time last year. One of our tenants, Fly-Glendale is finishing up a 20,000 square foot hangar building on the west side of the airport that should be in operation by the first of next year. The hangar will house their administrative functions, maintenance for aircraft, plane storage and support their flight school program. We are looking forward to seeing them!

Here's a look in to the future:

We are in the design phases for Taxiway Alpha and are planning on having it ready for construction next year and will likely phase it over the course of a couple. We are going to resurface it, and stabilize the shoulder areas by adding shoulders as well as removing and add some exits to the Taxiway. Construction will likely go in phases over the next couple of years.

Longer term we are developing a strategic plan for the airport and this vision/strategy will be our path going forward for development and operations. Once we receive comments from stakeholders we will take a look at the east side of the airport to see how we would like to develop it.

Q: Do you have a favorite quote?

A: I have two of them. "Be quick, but don't hurry," by John Wooden. "Good leaders set vision, missions, and goals. Great leaders inspire every follower at every level to internalize their purpose, and to understand that their purpose goes far beyond the mere details of their job," by Colin Powell.

Kyler will be working on various projects throughout the Region but will remain involved in several projects and airports within the Phoenix ADO. We anticipate Kyler will be returning to the ADO in late September.

- » ADOT Aeronautics would like to share its deep loss and thoughts to the family and friends of Mike Klein. Mike passed on July 28, 2020 after a 3-1/2 year battle with cancer. Mike spent 17 years with ADOT working in Aeronautics at various capacities to serve the airport community. Mike was a good friend and mentor to all of us here in Aeronautics and he is deeply missed and shall be forever fondly remembered.
- » Everyone at Aeronautics is well and is teleworking from home and will be until further notice. We expect teleworking shall continue after sometime after the first of the year. As always, you may contact us through email or our office phones and we shall respond as soon as we can.
- » Our Economic Impact Study is now underway. Sponsors may expect to be contacted from our representatives in the next few months requesting related information about your airport and community.
- » Sponsor ACIPS were required to ADOT no later than August 31, 2020. Please work with your respective grant manager if you are having any difficulties submitting.
- » Aeronautics has learned that the Legislature will NOT be sweeping the Aviation fund! We are therefore moving forward with having the Transportation Board approve the ACIP at the October Board meeting. We will be asking the Board to approve our full program with the exception that we will be moving \$5M originally set aside for the FSL program into the SL program. The SL program shall now have a new total of \$15M budgeted to it. Aeronautics shall be contacting sponsors in the next month or so to confirm if they shall be receiving one of these grants. SL grants shall be made available to sponsors once the State Board approves the program in October. Best of luck!

National Aviation Day *Continued.*

Although this year's Aviation Day has passed, here are some other fun ways to celebrate aviation on any day of the year with your colleagues, friends, and family:

1. Support and Visit an Aviation Museum

Arizona is home to several great aviation and aerospace museums. Some of the more prominent include the Pima Air and Space Museum in Tucson. It boasts more than 300 civilian, commercial, and military aircraft and spacecraft and is the world's largest non-government-funded aviation museum. Another local favorite is the Arizona Wing of the Commemorative Air Force located at Falcon Field Airport in Mesa. Aside from their large collection, you can even take a flight in a restored B-17 Flying Fortress (the Sentimental Journey) or a B-25 Mitchell. Other notable museums include the Titan Missile Museum, Planes of Fame Air Museum, and the "Boneyard" at Davis-Monthan Air Force Base.

2. Go to an Air Show or an Airport Fly-In

Several of the military bases, as well as numerous airports around the state, host air shows year-round. This is one of the best ways to experience all the wonder and excitement of flight because of the diverse aircraft, pilots, and volunteers that take part. On a smaller scale, airport fly-ins are fun ways for pilots and others to get together at one airport and enjoy time together.

3. Go Plane Spotting at Your Local Airport

So many airports in our state have great places to sit and watch the planes – from outdoor picnic areas, to restaurant balconies, or even just a parking lot. Take your kids with you and see how

many different planes they can point out, and don't forget to take some photographs and share them with AzAA.

4. Build a Paper Airplane, a Model Aircraft, or a Rocket

These simple tasks can be so much fun for young people to either get them interested in aviation or foster their love even more. There has been a great focus on science, technology, engineering, and math (STEM)-related programs for children and young adults in recent years, and aviation can incorporate all these things. And when you add in art, it becomes STEAM. Phoenix Sky Harbor International has one of the best airport museum programs in the country, and many of their exhibits are located pre-security in all terminals. Although not all their exhibits are aviation-themed, they do have a great aviation history collection that is showcased throughout the year.

5. Go Flying

The preferred way to celebrate is from the sky! If you have a pilot's license, go for a flight to your favorite AZ airport. If you have been wanting to learn to fly, go for it. Or, enjoy your next flight on a commercial airliner, even if it looks different this year than in the past.

These are just a few of the ways to celebrate aviation on National Aviation Day or any day of the year. This industry means something different to everyone – let whatever inspires your love of aviation be an inspiration to others, so they too can experience all the wonderful things the world of flight has to offer today and in the future.

Calling All Artists! Be a Part of the Cottonwood Municipal Airport's History!

COTTONWOOD, AZ – The City of Cottonwood Municipal Airport is calling all local artists to submit an original design for an aeronautical compass rose. The winner will paint their compass rose on the ramp at the Airport at approximately 50 feet in diameter as part of the national airmarking program. In addition to aesthetic appeal and creativity, the design must also incorporate the technical requirements of a usable

compass rose. An airport compass rose is used to calibrate the aircraft's magnetic compass. It is also often a unique airfield identifier found at many general aviation airports. Artists are encouraged to provide a design that incorporates the essence of Cottonwood. To download an informational flier with more information including compass rose examples visit cottonwoodaz.gov/compass-rose.

Contest Rules

Eligibility: Artists must live or work in the Verde Valley. Submissions may be made by individual artists or teams. Employees of the City of Cottonwood and their families are not eligible.

Submission: Entries may be submitted as either original artwork, photos of artwork, or as digital files (EPS, JPG, or PDF are acceptable digital file formats). Entries should be accompanied by examples of previous work by artist or team.

Deadline: Entries must be received no later than noon Wednesday, September 30. Hard-copy entries may be dropped off at City Hall (827 N. Main St.). Digital entries should be sent to pio@cottonwoodaz.gov.

Judging: A committee comprised of City employees will select five finalists. These entries will be posted, and the Cottonwood community will be invited to vote for their favorite. Whichever entry receives the most community votes will paint their compass rose on the ramp at the Cottonwood Municipal Airport. The timeline for judging is as follows:

- » **Finalists will be announced Wednesday, October 7.**
- » **Community voting will be conducted online through Wednesday, October 21.**
- » **The winner will be announced Friday, October 30.**

The winning compass rose will be painted on the Airport ramp by the winning artist, with paint and supplies paid for by the City.

Prize: The winner(s) will be taken on a ride with an aviator. A dedication ceremony and ribbon cutting are slated for Friday, November 20. The winner(s) and family members will be invited to participate in the dedication ceremony conducted by the City of Cottonwood.

It will be no surprise to any of you that I'm starting this President's Message by mining history. This time around, we'll dust off one of my favorite books about flying - *Wind, Sand, & Stars*.

Antoine de Saint-Exupéry, or "Saint-Ex" to his readers, was a man who arguably spent the most profound moments of his life completely isolated from the rest of the world. Shut inside a tiny cockpit, often over barren wastes of terrain or ocean, on long-distance runs to unheard of outposts, or on the solo reconnaissance mission on which he was lost in WWII, you never get the impression he was lonely, even though he wrote of isolation a great deal.

Saint-Ex has always been my favorite aviation author. And directly because of the recent isolation we have all experienced due to the current state of the world, I've had cause to revisit his work. I'm glad I did.

I've probably read all the same articles and participated in many of the same virtual meetings as many of you these past months. We all hear the projections which cut to the core of our industry. Projections that the airline industry alone will lose over \$84 billion in 2020 alone, continual worry about workforce preservation, and the overarching concern about the future of funding at all levels touch all of us daily. And unfortunately, all of us, I would wager, have been impacted by the virus. We are all doing our best to cope with our professional demands, made so much more acute by COVID, at the same time we are mourning the loss of family and friends.

Talking to our membership, I certainly hear these losses in the voices at the other end of the phone and see it in the faces looking back at me from my laptop. It's easy to feel disconnected and disconcerted right now. But I also see something else in our membership. It's what Saint-Ex saw when he looked back on all the times he thought he was alone, working quietly away at altitude otherwise removed from the rest of the world. What I see is the relationships we all have tended with one another. I see all the effort within the membership to with and care for one another.

What Saint-Ex said was this - *"We forget that there is no hope of joy except in camaraderie. It's useless to seek happiness elsewhere than in this warmth of relationships...It is not something discovered. It is something molded."*

At the end of every flight, Saint-Ex realized he had colleagues waiting, depending upon him to do his part. Those colleagues, he discovered, quickly became so much more to him. They became the people he depended upon, the people he called his friends.

Saint-Ex took his final flight in 1944, a year when the world was at the height of global conflict. Even through that war, he remained one of aviation's chief proponents - still believed in flying's potential to unify and to heal. I think Saint-Ex's dictum holds up and has been evidenced in you all, especially of late - *"What constitutes the dignity of a thing is that it creates a fellowship, that it binds together and fashions for us a common language."*

Thanks to you all for the amazing support you continue to provide to one another. Here's to looking forward to all the amazing work together in the coming year!
